# RULES AND TERMS AND CONDITIONS FOR THE CAMP FLOG GNAW 2024 X CONVERSE MERCH SWEEPSTAKES

# 1. Who is eligible?

This Sweepstakes is open only to legal permanent US residents who are 18 or older at the time of entry. Employees of Converse Inc., its parent company, Nike, Inc., their subsidiaries and affiliates (collectively "Converse"), or of other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children, and each of their respective spouses) and household members of each such employee are not eligible. ## 2. Who is sponsoring the Sweepstakes?

### 3. When Can I enter?

The Sweepstakes starts at 10:00AM ET on November 15, 2024 and ends at 2:59AM ET on November 18, 2024 (the "Entry Period"). Entries submitted prior to or after the Entry Period will be disqualified.

# 4. How do I enter?

There is a limit of one entry per person. Subsequent entries will be void.

### 5. How will winners be selected?

On or by December 1, 2024, the Sponsor will select one potential winner in a random drawing from all entries received. The odds of winning depend on the number of eligible entries submitted and received. The potential winner will be notified by email. If a potential winner declines to accept the prize, has violated any of these Official Rules, or fails to sign and submit the required documents, if any, within the required time period, then an alternate entrant may be selected, at Sponsor's discretion and if time permits, in his/her place in a random drawing of remaining eligible entries.

Prizes are not transferable and must be accepted as awarded. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited by law. # 9. How will disputes be handled?

Except where prohibited, entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Massachusetts. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the Commonwealth of Massachusetts, without giving effect to any choice of law or conflict of law rules (whether of the Commonwealth of Massachusetts or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Massachusetts.
